- 1.4. Stirling Investment S.a.r.l. reserves the right to change these terms at any time. We recommend that you always read these terms before booking, to satisfy yourself that you accept them.
- 1.5. These terms, along with all other relevant terms and conditions that are referred to in these terms and any other terms referred throughout the payment process, constitute the entire agreement between you and Stirling Investment S.a.r.l. with respect to the sale of the relevant services.
- 1.6. We are only supplying you with car parking under the contract and will not be responsible for any costs, compensation or expenses relating to any other services that you may have arranged.

# 2. Payment

- 2.2. When you have completed your registration having provided all the necessary details, we will send you email confirmation. You are responsible for supplying a valid email address and vehicle registration and we cannot be held responsible for non-delivery due to transmission failure or incorrect details provided by you.

# 3. Cancellations and Amendments

#### 4. Entry / Exit Procedures

- 5.7. No vehicle may park outside of a marked parking bay.

- 8.2. While Stirling Investment S.a.r.l. uses reasonable endeavors to ensure that the car parks are secure, Stirling Investment S.a.r.l. cannot be held liable for any loss or damage that may occur.
- 8.3. You must comply with all directional signage and other instructions when in the car parks.
- 8.4. We reserve the right to refuse admission for any vehicle to the car park for any reason whatsoever and may remove from the car park or move within the car park any vehicle by whatever method we consider reasonable at the expense of the user/owner.
- 8.5. We additionally reserve the right, where the car park must be closed either permanently or temporarily in whole or in part or must be evacuated in cases of emergency, to remove any vehicle at any time to any other reasonably convenient car park within the control of Stirling Investment S.a.r.l. or otherwise as may be practical.
